

O.A.S. Bird Fair Vendor Contract – March 3, 2012 "Spring Fling" Bird Fair

The Oklahoma Avicultural Society appreciates your cooperation in abiding by the following rules. If the O.A.S. finds any vendor in violation of these rules, the vendor will be required to immediately leave the fair and will forfeit all table rental fees.

1. Only exotic birds and bird-related items may be displayed or sold. NO mammals or reptiles will be allowed or sold in the O.A.S. Bird Fair Exhibition Hall.
2. Tables will be reserved only when O.A.S. has received a signed contract and table rental payment. Signed contract and payment for "Spring Fling" Bird Fair must be received by **February 1, 2012** to insure table reservation. **O.A.S. reserves the right to refuse applications for table rentals after that date.**
3. THE O.A.S. RESERVES THE RIGHT TO REFUSE ANY VENDOR THAT HAS BIRD(S) THAT, IN THE JUDGMENT OF O.A.S. VOLUNTEERS, APPEAR TO BE SICK OR IN UNSANITARY CONDITIONS. **THOSE BIRDS MUST BE REMOVED FROM THE BUILDING IMMEDIATELY.**
4. Birds shall be displayed in clean and proper size cages with appropriate amounts of food, water and adequate perch space. Vendors with excessive birds in a cage must remedy the condition immediately, or remove the birds from the building at the request of authorized O.A.S. volunteers.
5. Vendors will be responsible for keeping their own areas clean. All tables must be covered and tables with birds displayed out of cages must have coverings on the tables and floor. All birds out of cages must have a proper wing trim to prevent extended upward flight.
6. Only vendors with table space will be allowed to sell birds, products or services.
7. All vendors with birds are asked to provide a hand disinfectant to be used by anyone before handling the birds. This is a precautionary aid in the prevention of spreading disease.
8. Tables may only be moved with the consent of the O.A.S. Fair Chairman
9. Two vendors may split a table with the consent of the O.A.S. Fair Chair. BOTH vendors must sign a Vendor Contract.
10. Nothing may be attached to the walls except with special tape available at the O.A.S. Club table.
11. NO Smoking, Alcoholic beverages, Firearms or other Weapons are allowed in the Green Country Event Center or Bird Fair Exhibition area.
12. Other bird clubs and organizations may only distribute literature with the consent of the O.A.S. Fair Chair.
13. O.A.S. is not responsible for business transactions between buyers and sellers, such as bad checks, misrepresentation, taxes, illness of birds, etc.
14. Neither O.A.S nor any representative of O.A.S. shall be held liable for damage, injury, illness, loss (including loose birds) or theft to any person, bird or property for any cause whatsoever.
15. **CANCELLATIONS** - If a vendor cannot attend the Bird Fair, the Vendor must notify the O.A.S. Fair Chair AS SOON AS POSSIBLE. No refunds will be given after the date of the fair.
16. Paid tables will be held until 10:00 a.m. the day of the fair. If no prior arrangements have been made with the Fair Chair, the tables may be resold, and the table rental fees will be forfeited by the Vendor. **RETURNED CHECK FEE: \$25.00**
17. ALL table assignments will be made at the discretion of the O.A.S. Fair Chair.
18. **Each Vendor MUST complete the furnished form listing all birds sold, including names and addresses of purchasers, and submit the form to the O.A.S. Fair Chair. This is a REQUIREMENT of the Oklahoma Department of Agriculture effective July 1, 1998. This list will be sealed and is required to be kept for 30 days should a human transmittable disease be reported. After 30 days, the list will be destroyed.**

O.A.S. promotes the sale and purchase of only those baby birds that have been properly weaned to persons who are very experienced hand feeders. At the O.A.S. Bird Fairs, educational materials which explain the dangers and dispel the myths of selling or purchasing unweaned baby birds are available to everyone. We encourage all vendors who attend O.A.S. Bird Fairs to first consider the health and wellbeing of the babies they've bred, and to sell only those that are properly weaned.
